Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on February 18, 2020, February 21, 2020, and February 25, 2020, makes reference to County Communication 19-29, from Council Chair Kelly Takaya King, relating to litigation matters.

By correspondence dated September 5, 2019, the Department of the Corporation Counsel requested consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30181452447-0003 OF KEVIN BARHAM."

The purpose of the proposed resolution is to authorize the Department to settle the claim.

The Department also transmitted a copy of the claim and documentation relating to the personal injury claim.

Your committee notes the claim alleges personal injuries sustained by Mr. Kevin Barham in a collision with a Maui County fleet vehicle on November 1, 2018.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the claim. He said the incident occurred on Honoapiilani Highway in Lahaina, Maui, Hawaii. The County vehicle was being driven by an employee of the Department of Police.
