FY2023 = \$75.5 M

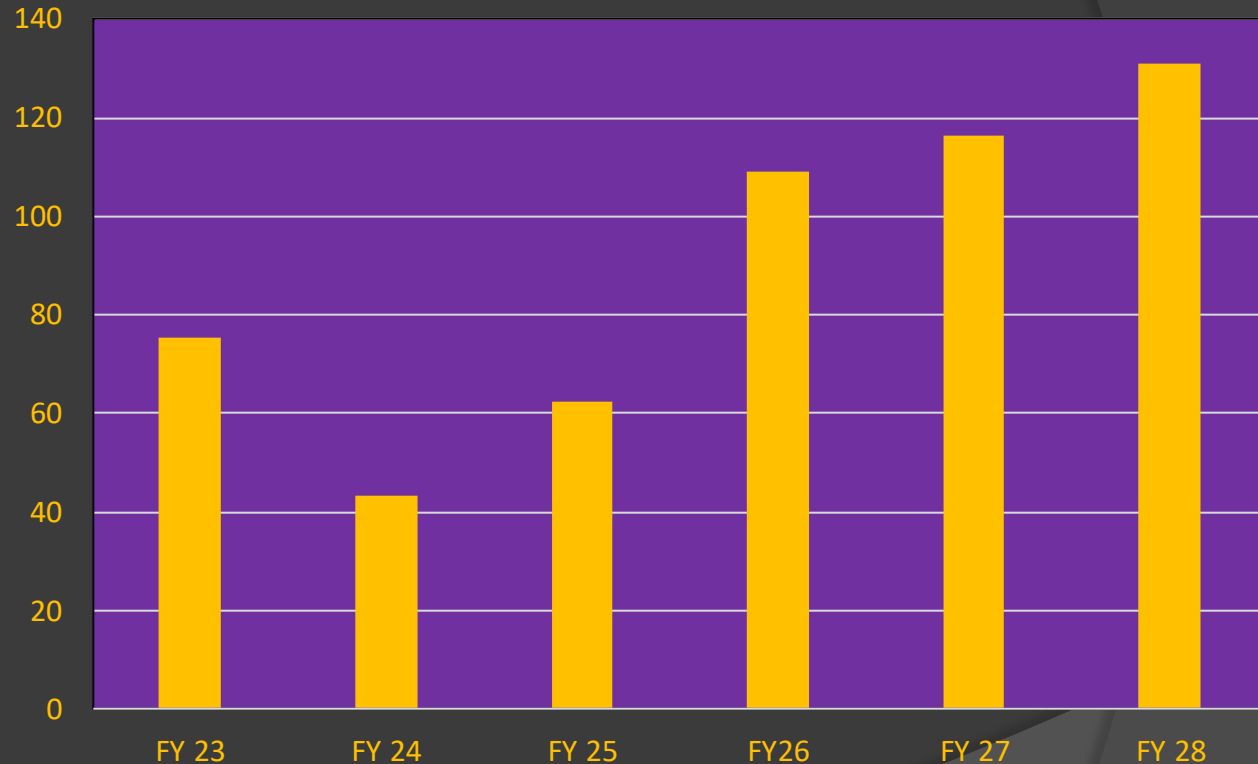
FY2024 = \$43.3 M

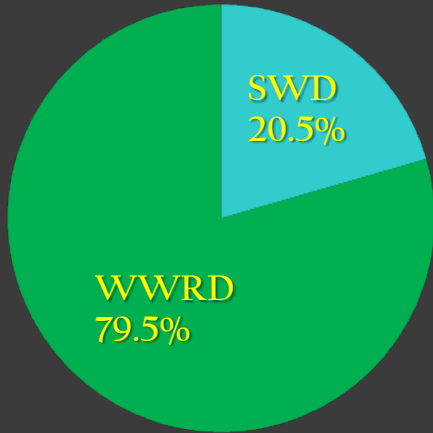

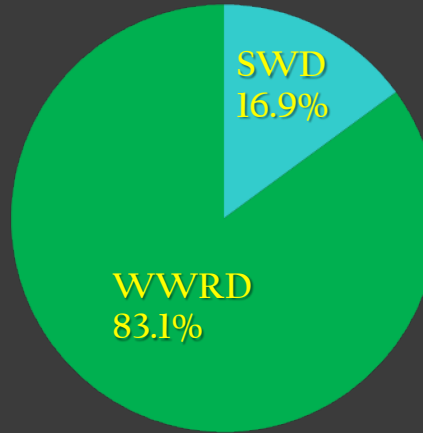

FY23-FY28 CIP Budget by Division

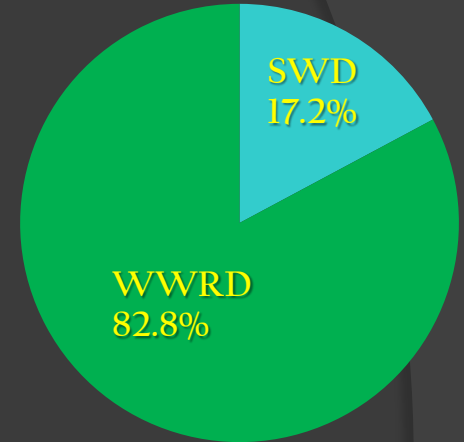

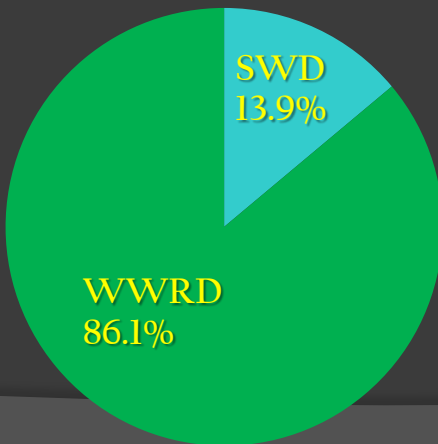

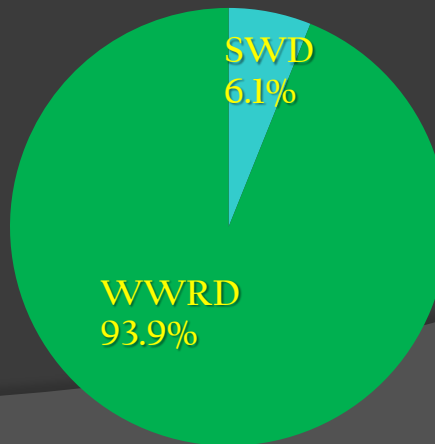

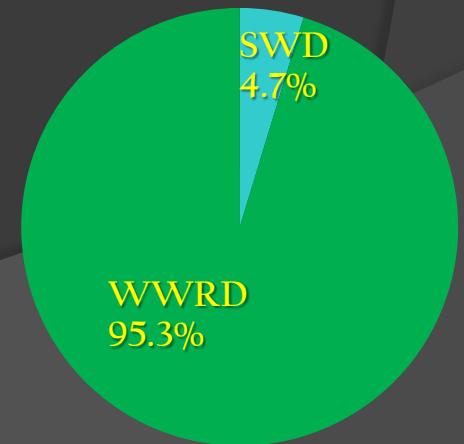

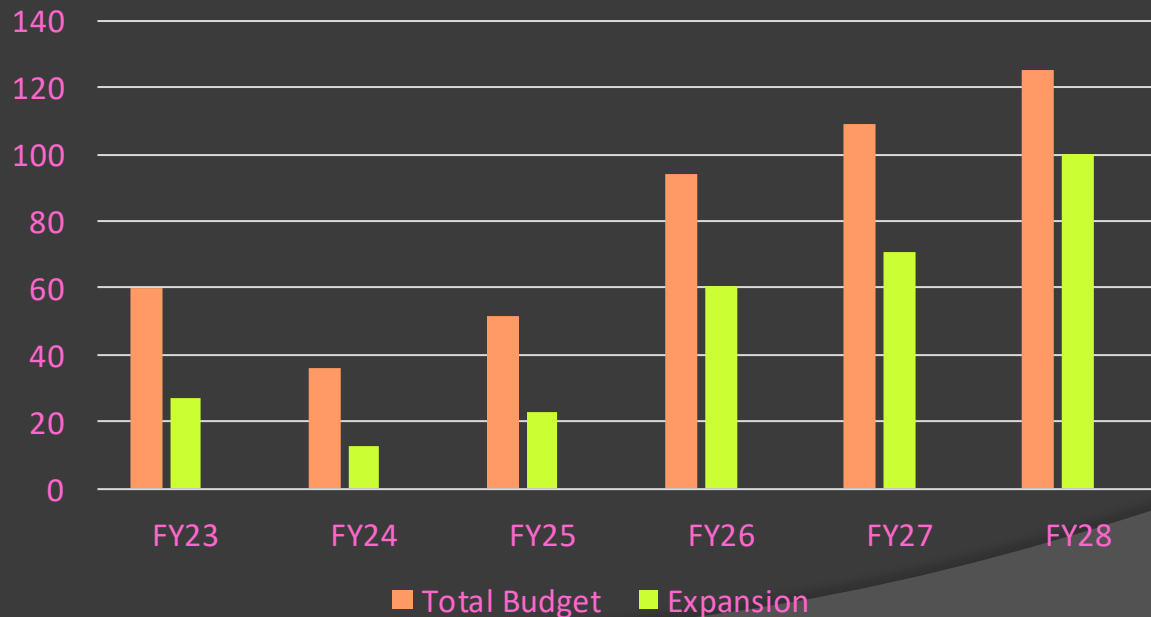

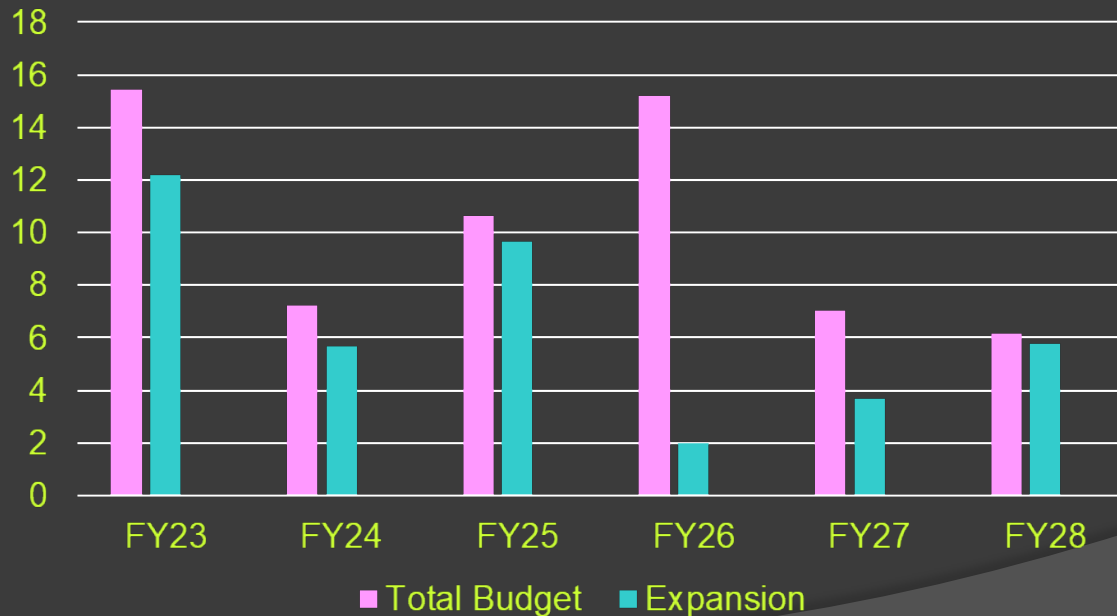
