ACTING ON THE NOMINATION OF JEREMY DELOS REYES AND BRIALYN KAUIONALANI TOSHIKO ONODERA TO PUBLIC WORKS COMMISSION

WHEREAS, the Public Works Commission was formed and operates with nine members and two alternates under Section 2.40.220 and Section 2.98.010, Maui County Code; and

WHEREAS, four vacancies will occur on the Public Works Commission when the existing terms expire on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr., notified the Council he nominated Jeremy Delos Reyes and Brialyn Kauionalani Toshiko Onodera, listed on Exhibit "A," as attached, as members to the Public Works Commission; and

WHEREAS, the nominations are made in accordance with Section 2.40.220 and Section 2.98.010, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the Mayor's nomination within 30 days after the Mayor submits the name of the nominee to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now therefore,

BE IT RESOLVED by the Council of the County of Maui:


1. That it approves the appointment of the persons listed in Exhibit "B," as attached, as members to the Public Works Commission for the term expiring on March 31, 2031;
