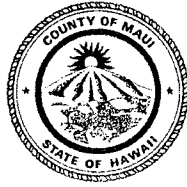

WHEREAS, by correspondence dated June 21, 2019, Mayor Michael P. Victorino notified the Council that he nominated Jamie Becraft to the Liquor Control Commission for the County of Maui for a term expiring March 31, 2023, to fill a vacancy replacing Jonathan Todd, pursuant to Sections 8-13.2 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and
