I was arrested twice and stood trial regarding the illegality of nuclear weapons.

This morning I spoke with my 97-year-young kupuna, Shirley Morrison - who I was arrested with - twice. She sends her Aloha and joins with me in these statements.

The proposal before the Lana'i Planning Commission is to approve an airport for a drone that will fly at 80,000 feet high and beam 5G radiation throughout much of Maui county. The effects on life of beaming 5G wireless radiation into the land, into the ocean, into our homes and into our bodies is extremely dangerous for humans and all other living organism.

Thousands of peer reviewed research studies document the adverse effects of wireless radiation on humans and other living things.

According to federal and international law, what is being proposed is unlawful.

In order to establish a permanent Internet presence in the stratosphere, Google, University of Hawai'i and defense contractor, AeroVironment, are proposing nothing less than defacto human experimentation.

In order for a human experiment to be ethical it MUST include informed consent and the ability to OPT OUT. In this case, there is no opportunity to give informed consent, nor an option to OPT OUT. Therefore this proposal is not only unethical, but according to the Nuremberg Trials and Principles, Helsinki Accord, the 1994 Cold War Hearings, and U.S. military law - it is unlawful.

YOU DO NOT HAVE MY CONSENT.

It would be nothing less than a CRIME against humanity.
According to the above referenced laws, neither science, the future nor national security justify human experimentation.

Given that the damage would go beyond the intended target in distance, and in time, it would also constitute a Weapon of Mass Destruction.

YOU DO NOT HAVE MY CONSENT.

It is critical that we do everything within our power to STOP this lethal proposal. This 5G drone is so experimental that almost no regulations exist to govern it. Both of the previous drones built by AeroVironment have crashed.

This massive HAWK30 drone proposed for Lana'i is an extremely complex project that has impacts far beyond Lana'i and should be adjudicated at the County level.

I expect you to protect us.
