This testimony is in support of the appointment of David C. Goode as the Director of Public Works of Maui County. I am Lynn McCrory, Senior Vice President of Government Affairs for Pulama Lānaʻi. Pulama Lānaʻi is the entity that was set up by Larry Ellison to work with the community and government as we move the island of Lānaʻi toward sustainability.

We have worked with David Goode over the last six years in his position as Director of Public Works on numerous permits and questions. We found many issues on Lanai in which what had been done or not done previously, could be handled and handled quickly and appropriately. The answers that we received were complete and clear. We knew how to go forward to be sure that what we were doing or going to do would meet the regulations that were in place.
