Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on October 1, 2019, makes reference to County Communication 19-29, from Council Chair Kelly T. King, relating to litigation matters.

By correspondence dated April 26, 2019, the Department of the Corporation Counsel requested consideration of the possible settlement of Claim 30180343818-0001 by Garrison Property and Casualty Insurance Company, on behalf of its insured Alan Ditch. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30180343818-0001 OF GARRISON PROPERTY AND CASUALTY INSURANCE COMPANY, ON BEHALF OF ALAN DITCH." The purpose of the proposed resolution is to authorize the Department to settle the claim for \$8,043.81.

The Department also transmitted a copy of the claim and documentation relating to damages associated with the claim.

Your Committee notes the claim alleges damages to Alan Ditch's vehicle resulting from an unsecured gate that swung open on June 4, 2018, at Maui Lani Regional Park ("Park"), Kahului, Maui, Hawaii.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the case. He said the incident occurred as Mr. Ditch was exiting the Park. The matter was investigated by the Department of Police, which confirmed the claim was valid.


The representative of the Department of Parks and Recreation said it is uncertain how the gate that hit Mr. Ditch's vehicle became unsecured. The incident prompted the Department to change its parks' gates to a new design that prevents them from swinging open or closed.

Your Committee agreed settlement of the matter is warranted.

Your Committee voted 7-0 to recommend adoption of the proposed resolution. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Kama, Lee, Paltin, Sinenci, and Sugimura voted "aye." Committee members Hokama and King were excused.

Your Governance, Ethics, and Transparency Committee **RECOMMENDS** that Resolution \_\_\_\_\_, attached hereto, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 30180343818-0001 OF GARRISON PROPERTY AND CASUALTY INSURANCE COMPANY, ON BEHALF OF ALAN DITCH," be **ADOPTED**.

WHEREAS, the County of Maui and Garrison Property and Casualty Insurance Company, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, have reached a proposed resolution of this claim by way of a negotiated settlement; and

WHEREAS, having reviewed the facts and circumstances regarding this matter and being advised of attempts to reach resolution of this claim by way of a negotiated settlement by the Department of the Corporation Counsel, the Council wishes to authorize settlement; now, therefore,

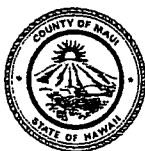

## Synopsis

Alan DITCH reported that on 06/04/18 at about 1208 hours, he was traveling (E) within the parking lot of Maui Lani Regional Park (directly across Amoa Street in Kahului) when the wind caused the unsecured park entry/exit gate to swing open and strike the front right bumper of his vehicle bearing Hawaii license plates LHE845. As a result, his vehicle sustained damages to the front right bumper. DITCH was not injured in the collision nor was he observed to have any physical injuries. Checks of the park gate revealed the left side gate partially bent. Both left and right side gates were unable to be secured. All damages are estimated at under \$3000.00. DITCH will contact the County of Maui Parks and Recreation to file a claim. Report for records.

#### ASSIGNMENT:

On 06/08/18 at approximately 1107 hours, I was assigned to conduct follow-ups regarding a damage claim that had been received by the County of Maui. Per County of Maui Deputy Corporation Counsel Moana LUTEY police assistance was being requested to determine if the complainant's, identified as Alan DITCH, sequence of events could be plausible.

#### REVIEW OF PHOTOGRAPH AND POLICE REPORT:

A review of the photograph of the gate in question revealed damages to the paint at the bottom of the end. Further review revealed no damages to the paint in the center of the gate in the area where it was folded. This indicates the gate was struck on the end causing it to fold as was described in DITCH's sequence of events.

A review of the police report reveals Officer Cody SALUDEZ collected this report at another location.

#### OFFICER'S CONFERRAL:

On 06/08/18 at approximately 1200 hours, contact was made with Officer SALUDEZ. Officer SALUDEZ related he did remember this case. He further related after collecting the the necessary case information to make checks on the gate in question.

Officer SALUDEZ related he did observe the gate to be unsecured and damaged in the manner DITCH had described.

#### ADDITIONAL PHOTOGRAPHS:

On 06/15/18, at approximately 0901 hours, contact was made Alan DITCH. DITCH related he had

photographs of the damages his vehicle sustained. Checks of these photographs revealed the damages to be in the location described in this report and the damage claim submitted.

Further examination revealed what appears to be collision debris in the driveway approximately two feet from the grass edge. This indicates the collision occurred on the travel portion of the driveway.

### CONCLUSION:

As of this writing there is no evidence that the sequence of events described in both this report and the claim submitted to the County of Maui is fraudulent.
