WHEREAS, pursuant to Section 3-6 of the Revised Charter of the County of Maui (1983), as amended ("Charter"), the Council has the authority to conduct investigations of the operation of any department or function of the County and any subject upon which the Council may legislate; and


WHEREAS, the Department of Transportation is responsible for the oversight and support of transportation systems that facilitate the movement of people throughout Maui County, including public transit, commuter, paratransit, and human services transit in a safe, efficient, and cost effective manner; and

BE IT RESOLVED by the Council of the County of Maui:
