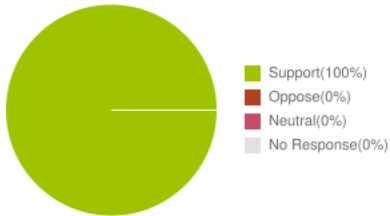

Overall Sentiment



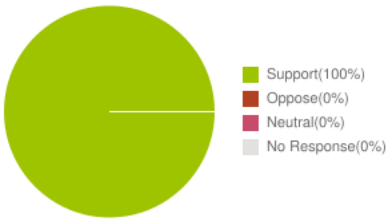

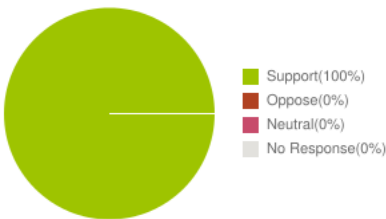

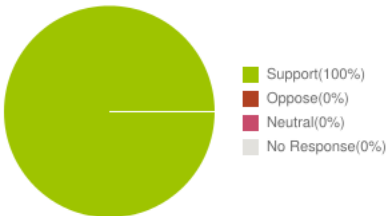

Dear Chair, Vice-Chair, and Committee:

My name is Amy Johnson and I am the Chief Development Officer for the Maui Family YMCA. I am submitting this written testimony in support of Bill 8 (2024), Amending the Fiscal Year 2024 Budget: Office of the Mayor (Administration Program).

The appropriation of \$200,000 for Maui Family YMCA is part of a larger program that expands on the existing partnership established between Maui Family YMCA and Grow Some Good which transformed 1/4 acre into garden spaces with fruit trees, vegetables and other indigenous edibles.

The funding initiates work on a two acre parcel adjacent to the Y facility to create a sustainable, intergenerational community food forest that offers the benefits of horticultural therapy, educational opportunities, workshops, and social enterprise programs that serve underprivileged and disaster affected communities across Maui. Additionally, the program addresses critical wellness needs of the community, giving underserved and economically disadvantaged populations access to services promoting healthy lifestyle awareness and overall wellness.

Maui Family YMCA has been serving residents since 1960 and we are very appreciative of the support of the County of Maui and other public and private organizations. These funds will allow us to build on existing programs and create a sustainable and valuable asset for the community.

Aloha Chair Sugimura, Vice Chair Kama and members of the Committee,

The Construction Industry of Maui (CIM) would like to SUPPORT Bill 4 which amends the Fiscal Year ("FY") 2024 Budget, Appendix A, Part II, Affordable Housing Fund, by adding new conditional language for the Kilohana Makai Project stating, "Up to \$4,929,088 must be for a grant to Aina Lani Pacific, LLC for on-site infrastructure for the Kilohana Makai project at TMK (2) 3-9-004:141, Kihei, Maui, Hawai'i."

Housing projects such as this are critical to our island community but face strong headwinds due to high interest rates, material cost increases and a deepening skilled trade deficit which has drastically increased labor costs. Whereas infrastructure is often the costliest portion of a housing project, this grant would be of great benefit for this project and the developer who has taken on a substantial risk to make affordable housing a reality for the people of Maui.

We applaud both the Council's willingness to appropriate these funds for this much needed project and Aina Lani Pacific, LLC for its inclination & tenacity to build affordable housing on Maui.

Testimony in SUPPORT of Bill 4 (2024)

Aloha Chair Sugimura, Vice Chair Kama and members of the Committee,

The Maui Chamber of Commerce would like to **SUPPORT Bill 4** which amends the Fiscal Year ("FY") 2024 Budget, Appendix A, Part II, Affordable Housing Fund, by adding new conditional language for the Kilohana Makai Project stating "Up to \$4,929,088 must be for a grant to Aina Lani Pacific, LLC for on-site infrastructure for the Kilohana Makai project at TMK (2) 3-9-004:141, Kihei, Maui, Hawai'i."

Housing is a top priority for the Maui Chamber of Commerce and continues to be so as the crisis escalates following the wildfires and it directly impacts businesses and our economic revitalization. Before the wildfires, we needed over 10,000 units by 2025, but that number has only increased as 3% of our housing was lost in Lahaina. Urgent funding and strong political support are critical to have units built expeditiously as prices to build are continuing to increase.

This project has gotten a lot of support from the community. The developer is from Maui and is a Director of the Maui Chamber of Commerce and a member of the Chamber's Construction Industry of Maui trade council, which we wanted to note in the interest of full disclosure. That said, you will find our support of this housing project is in line with other housing projects we have supported over the last decade in our efforts to help meet the housing needs of our community.

The developer has already entered into contracts with the home buyers who were able to lock in lower interest rates at the time of contract. As you can see, the demand is there and people are ready to go.

Continuous delays on granting funding are part of the reason housing costs are so high. Let's get this project going sooner rather than later, please!

For these reasons we urge that **Bill 4 (2024) be passed** as soon as possible.

Testimony in SUPPORT of Bill 11 (2024)

Aloha Chair Sugimura, Vice Chair Kama and members of the Committee,

The Maui Chamber of Commerce would like to **SUPPORT Bill 11** which amends the Fiscal Year 2024 Budget, Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology by: 1) reducing Sports and Events Promotion, Category B - Operations & Equipment and the Total by \$111,032 and to delete "for sporting events" after "student travel"; 2) reducing Technology in Business Promotion, Category B - Operations & Equipment and the Total by \$388,968; and 3) adding a new appropriation for "Hone Heke Corporation" in the amount of \$500,000."

The Chamber notes that Hone Heke is the parent corporation of Expeditions, which operates the Lana'i Ferry and is a longstanding member of the Maui Chamber of Commerce. The company lost their office, computers, services, and all records during the August 8 wildfires. As a result of losing their ability to load in Lahaina Harbor, Expeditions had to move their operations to the Maalaea Harbor. In order to facilitate faster operations, the ferry had to be moored in Maalaea Bay. A recent storm caused Expeditions 5 to come loose from the mooring and the boat was grounded on a reef. Thus, adding more expense to trying to perform a critical service the residents of Lana'i. The proposed funding would be used for equipment and operations costs to ensure ferry service is able to continue while additional funding is sought.

For these reasons we strongly urge that **Bill 11 (2024) be passed** as soon as possible.
