

## RELATING TO THE APPOINTMENT OF PETRINA CASTILLO TO THE MAUI COUNTY COMMISSION ON PERSONS WITH DISABILITIES

WHEREAS, by correspondence dated May 22, 2017, Acting Mayor Keith A. Regan notified the Council he nominated Petrina Castillo to the Maui County Commission on Persons with Disabilities for a term expiring on March 31, 2022, to fill a vacancy replacing Victor Lesa, pursuant to Sections 2.32.020 and 2.32.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Petrina Castillo to serve on the Maui County Commission on Persons with Disabilities for a term expiring March 31, 2022;
2. That the Council expresses its gratitude and appreciation to Petrina Castillo for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
