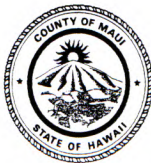

RELATING TO THE APPOINTMENT OF RANDON ALIKA SANCHES TO THE COST OF GOVERNMENT COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated May 3, 2022, Mayor Michael P. Victorino notified the Council he nominated Randon Alika Sanches to the Cost of Government Commission for the County of Maui for a term expiring on March 31, 2023, to fill a vacancy replacing Noemi Barbadillo, pursuant to Sections 3-9.3 and 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

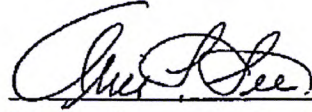
WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it disapproves the appointment of Randon Alika Sanches to serve on the Cost of Government Commission for the County of Maui for a term expiring March 31, 2023;
2. That the Council expresses its gratitude and appreciation to Randon Alika Sanches for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.

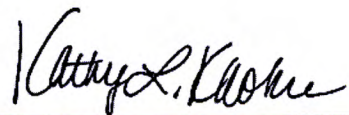
