



ADOPTING THE FUEL TAX RATES FOR THE
COUNTY OF MAUI, EFFECTIVE JULY 1, 2017

BE IT RESOLVED by the Council of the County of Maui:


1. That, in accordance with Section 243-5 of the Hawaii Revised Statutes and Section 3.20.010 of the Maui County Code, the fuel tax rates, effective July 1, 2017, shall be set as follows:

HIGHWAY FUND

<u>Fuel Tax - Maui, Molokai, Lanai</u>	<u>Tax Rate Per Gallon</u>
Gasoline & Diesel Oil	\$0.230
Biodiesel	\$0.060
Ethanol	\$0.115
Methanol	\$0.115
Liquefied Petroleum Gas	\$0.115
