AUTHORIZING THE ISSUANCE OF PERMITS FOR DURATIONS GREATER THAN FIVE CONSECUTIVE DAYS FOR THE 2017-2021 ALOHA CLASSIC WINDSURFING TOURNAMENTS, PURSUANT TO SECTION 13.04A.100, MAUI COUNTY CODE

COUNTY WHEREAS, the OF MAUI. INTERNATIONAL WINDSURFING TOUR. and US WINDSURFING ASSOCIATION, (hereinafter collectively referred to as the "Organizers"), desire to hold the Aloha Classic Windsurfing Tournaments ("Aloha Classic") at Hookipa Beach Park, as more specifically set forth in Exhibits "A" and "B." attached hereto and made a part hereof; and

WHEREAS, this professional and international event supports the North Shore community and promotes Maui as a destination on an international platform for the sport of windsurfing; and

WHEREAS, in accordance with Section 13.04A.100(D), Maui County Code, a use permit for activities at any County park or recreational facility for more than five consecutive days requires approval by the Council of the County of Maui; and

WHEREAS, the Organizers intend to have eleven competition days and an additional period of three days to accommodate inclement weather conditions, for a total of fourteen consecutive days for each

event as follows: October 29, 2017 to November 12, 2017; October 28, 2018 to November 11, 2018; October 27, 2019 to November 10, 2019; October 25, 2020 to November 8, 2020; and October 31, 2021 to November 14, 2021; and

WHEREAS, the Organizers have duly applied for a special event permit with the Department of Parks and Recreation for the 2017 - 2021 Aloha Classic; and

WHEREAS, the Department of Parks and Recreation seeks Council authorization to issue the requested special event permit exceeding five consecutive days for the 2017 - 2021 Aloha Classic; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it does hereby authorize the issuance of a special event permit exceeding five consecutive days for the 2017 2021 Aloha Classic; and
- 2. That certified copies of this resolution be transmitted to the Mayor and the Director of Parks and Recreation.
