CHASE, VERALYN LATHAM, NORMAN "BUSH"  
MARTIN, JR., AND LURLYN SCOTT TO THE  
EAST MAUI REGIONAL COMMUNITY BOARD,  
UNDER SECTION 8-19.2, REVISED CHARTER  
OF THE COUNTY OF MAUI (1983), AS  
AMENDED

WHEREAS, the East Maui Regional Community Board was formed and operates with 11 members under Section 8-19.2 of the Revised Charter of the County of Maui (1983), as amended, with the Mayor appointing four members and the Council seven; and

WHEREAS, the Council is the appointing authority for two vacancies that will occur on the East Maui Regional Community Board when the terms of Norman "Bush" Martin, Jr., and Lurlyn Scott expire on March 31, 2026, after they were appointed by the Council on June 23, 2023; and

WHEREAS, Charter Section 13-2(5) says that members of any board or commission initially appointed for a term not exceeding three years are eligible to succeed themselves for an additional term; and

WHEREAS, by correspondence dated December 31, 2025, the Independent Nomination Board transmitted to the Council four nominations; which are listed in Exhibit "A" with corresponding applications in Exhibit "D," including necessary redactions to protect confidential information; and

WHEREAS, under Charter Section 13-2(17), the Council has 30 days, or until January 30, 2026, to approve the appointment of nominations to fill the vacancies; and

WHEREAS, under Charter Section 13-2(20), if the Council does not fill one or both of the vacancies, the Council will notify the Independent Nomination Board by January 30, 2026, and request a new list of nominations; now, therefore,

From a young age, I learned the indigenous knowledge regarding the ahupua'a, native species in the streams, and acquiring and understanding the importance of water/water flow gaining firsthand conservation and cultural experience.

The numerous days spent with kupuna learning and experiencing the purpose of mauka to makai, water from the tops of the watershed to the marine environment, and endemic life forms that are dependent on pristine habitats throughout each land and water system were incredibly valuable. I also believe in incorporating both traditional and western knowledge to improve the sustainability of Ke'anae-Waiuanui Ahupua'a.

I believe in incorporating both traditional and western knowledge to improve the sustainability of Ke'anae-Waiuanui Ahupua'a. I am knowledgeable of the Ko'olau Watershed, streams throughout Ke'anae-Waiuanui, familiar with marine life and believe in educating, perpetuating, serving, and protecting the historical, spiritual, traditional and environmental well-being of Ke'anae-Waiuanui Ahupua'a.

In addition, Na Moku Aupuni o Ko'olau Hui conducts monthly community work days involving stream management and cleaning.




Figure 13. Upcountry Maui, Water System Service Area
