**SUBJECT: INTEGRATED PEST AND ENVIRONMENTAL
MANAGEMENT ON COUNTY PROPERTY (IEM-52)**

I have attached a copy of your February 29, 2016 response to my correspondence of February 9, 2016. As you may be aware, this matter was referred to the Infrastructure and Environmental Management Committee on February 26, 2016.

May I please request that you provide the following additional information so that the Committee may discuss this matter on March 22, 2016:

1. Pesticides listed on Page 2 of the attachment to your response correspond with an application amount, but not the total quantities used. Please specify the pesticides used by your Department during Fiscal Years 2014, 2015, and 2016, specifying brand name and quantity used by month.
2. Please clarify that Roundup or any other pesticide containing glyphosate is not currently used by the Department. Should such a pesticide have been used in the past please let us know when that use was stopped.
3. Kamaole 1, 2 and 3, as well as Rice Park are not listed. Could you please clarify that pesticides are not used at these locations? Please see attached photos indicating where pesticides appear to have been used.
4. Similarly, please clarify the extent of spraying around Pukalani fields. It appears that the perimeter of the fields near Pukalani Elementary

and preschool are being sprayed. Please state your understanding of the responsibility for this area. The attached photos are for your reference. The indicated area is to the right of the blue-tiled roofs on the school property.

I would appreciate your written response by **Monday, March 21, 2016**. To ensure efficient processing, please include the relevant Committee item number in the subject line of your response.

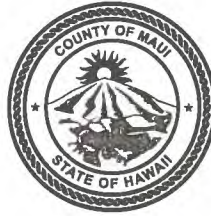
