Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2025, is amended to add a new appropriation under the Department of Public Works, entitled "United States Department of Agriculture, Natural Resources Conservation Service", in the amount of, \$4,783,442, to read as follows:
