Homeless Division – Housing First Approach

- Housing First does not require people experiencing homelessness to address all of their issues, including behavioral health problems, or to graduate through a series of service programs before they can access housing. Housing First also does not mandate participation in services before obtaining housing or in order to retain housing.
- The Housing First approach can benefit both homeless families and individuals with any degree of service needs. It can be applied to assist those that need a lighter touch, who may have experienced a temporary personal or financial crisis and also those who have high needs, such as chronically homeless individuals.
- Utilization of a coordinated entry system for the homeless services providers to objectively receive referrals.

Coordinated Entry System (CES)

- The Homeless Division is tasked with the administration of the HUD mandated Coordinated Entry System for Maui County, which is the operational arm of the Housing First approach.
- The CES is a process developed to ensure that all people experiencing a housing crisis have fair and equal access and are quickly indentified, assessed for, referred, and connected to housing and assistance based on their strengths and level of need.
- The CES utilizes the Homeless Management Information System (HMIS), which is a highly refined and robust database that collects client-level data, as well as data on the provision of housing and service organizations.
- The Homeless Division sits on the board that created and steers the policies and procedures of the Coordinated Entry System for the Balance of State (Maui, Hawaii, and Kauai Counties).
- Having a CES, Maui County was able to receive 76 HUD Emergency Housing Vouchers.


Placements via the CES

2021 Coordinated Entry System Placements into Permanent Housing – Subcategories

Maui County:

- ► 5% Veterans
- ■11% Kupuna
- ■25% Children
 - ■44% of children were <5 years old
- ► 57% Lived in Hawaii 20+ years
- 1% Lived in Hawaii <1
- 189 Families with Minor Children





- 23 pallet shelters located at Waiale Park in May 2020
 - 8x8 units with A/C and electrical outlets
- Utilizes park bathroom
- Family Life Center provides a mobile hygiene unit with
 - ▶ 3 shower stalls
 - 2 Washers/2 dryers
- 24 hour security
- Dinners provided
- ► FLC took over management of the project in November 2020
 - Providing case management
 - Focus on placing residents into permanent housing
 - >80% success rate of placements into permanent housing

This project demonstrated the effectiveness of a strong partnership and collaboration between public and private entities to achieve the desired outcome of ending the homelessness for individuals and families that have lived unsheltered for many years, some even generational.

Wahi Ho'omalu o Wailuku -Partnerships that's making it work

- Constructed by the Maui County Fire Department and the National Guard
- Site provided by the Department of Parks and Recreation who also maintains the facilities
- The Maui Humane Society for assisting with supplies and care for pets
- Ka Hale A Ke Ola for the use of their mobile hygiene unit and for providing a portion of the meals
- Maui County Emergency Management Agency for supplying basic necessities and PPE
- Family Life Center for continuing the work to permanently house the tenants
