## DISAPPROVING THE APPOINTMENT OF ANDREW H. MARTIN AS PROSECUTING ATTORNEY

WHEREAS, by correspondence dated January 20, 2021, Mayor Michael P. Victorino notified the Council he appointed Andrew H. Martin as the Prosecuting Attorney, in accordance with Sections 6-2(5) and 8-3.2 of the Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, Charter Section 6-2(5) requires the Council to confirm or deny the appointment within sixty days after receiving notice of the appointment by the Mayor; and

WHEREAS, Charter Section 8-3.2 states: “The prosecuting attorney shall be appointed by the mayor with the approval of the council”; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it disapproves the appointment of Andrew H. Martin as the Prosecuting Attorney; and
2. That a certified copy of this Resolution be transmitted to the Mayor.
