## Resolution

AUTHORIZING THE TRANSFER OF AN UNENCUMBERED APPROPRIATION BALANCE WITHIN THE OFFICE OF THE MAYOR, FISCAL YEAR 2025 BUDGET

WHEREAS, Section 9-10(2) of the Revised Charter of the County of Maui (1983), as amended ("Charter"), provides that, upon written request of the Mayor, part or all of any unencumbered appropriation balance may be transferred within a department by resolution or from one department to another by ordinance; and

WHEREAS, Section 7 of the General Budget Provisions in Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended, ("Fiscal Year 2025 Budget"), states that, unless otherwise provided, appropriations for each program may be disbursed for the following categories of use: (A) salaries, premium pay, or reallocation pay, and (B) operations, services, and equipment; provided the disbursement is within the program and category of use for which it was appropriated; and

WHEREAS, Section 3.B.12.d of the Fiscal Year 2025 Budget, relating to the Office of the Mayor, sets forth appropriations for the Community Development Block Grant Program; and

WHEREAS, in accordance with Section 9-10(2) of the Charter, Mayor Richard T. Bissen, Jr. has submitted a written request to transfer an unencumbered appropriation balance of \$215,000 within the Office of the Mayor, Community Development Block Grant Program, Category B (Operations & Equipment), to the Community Development Block Grant Program, Category A (Salaries), in order to cover \$215,000 in costs for staff to begin program design and development for the Community Development Block Grant – Disaster Relief Program; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That, pursuant to Section 9-10(2) of the Charter and Section 7 of the General Budget Provisions, and in accordance with the Fiscal Year 2025 Budget, it does hereby authorize the transfer for the Office of the Mayor, of an unencumbered appropriation balance of \$215,000 within the
