AUTHORIZING SETTLEMENT OF JMC CLAIM 4088770, COUNTY OF MAUI RISK FILE 2024-0068 OF MERC COIMBRA AND ALISA COIMBRA

WHEREAS, on March 18, 2024, Claimant Merc Coimbra filed JMC Claim 4088770, County of Maui Risk File 2024-0068, for property damage sustained on February 8, 2024, alleging a water main break flooded his home located at 276 Kaiola Place, #101 in Kīhei, Hawaiʻi 96753, which he owns with his wife, Co-claimant Alisa Coimbra; and

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a resolution by way of a negotiated settlement or Offer of Judgment; and

WHEREAS, having reviewed the facts and circumstances regarding this case and being advised of attempts to reach a resolution by way of a negotiated settlement by the Department of the Corporation Counsel, the Council wishes to authorize the settlement; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That under Section 3.16.020, Maui County Code, it approves settlement of JMC Claim 4088770, County of Maui Risk File 2024-0068 by Merc Coimbra and Alisa Coimbra in the amount of \$45,291.47;
- 2. That it authorizes the Mayor to execute a Release and Settlement Agreement on behalf of the County, under terms and conditions as may be imposed by the Corporation Counsel consistent with the Council's settlement approval;
- 3. That it authorizes the Director of Finance to satisfy the settlement of this case, under terms and conditions as may be imposed by the Corporation Counsel, consistent with the Council's settlement approval; and
