AUTHORIZING SETTLEMENT OF DEPARTMENT OF HEALTH, STATE OF HAWAII V. DEPARTMENT OF WATER SUPPLY, COUNTY OF MAUI, DOCKET 2022-CW-EO-11

WHEREAS, Complainant Department of Health, State of Hawaii filed a Notice of Violation and Order on March 15, 2022, Docket 2022-CW-EO-11, against the County of Maui, alleging effluent violations at Maui Department of Water Supply's Iao Surface Water Treatment Plant at Wailuku, Maui, TMK: (2) 3-5-001:067. Maui Department of Water Supply's National Pollution Discharge Elimination System permit for the Facility, Permit HI0021885 (Prior Permit), expired on November 30, 2021. Maui Department of Water Supply did not timely renew the Prior Permit; and

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a resolution of this case by way of a negotiated settlement or Offer of Judgment; and

WHEREAS, having reviewed the facts and circumstances regarding this case and being advised of attempts to reach resolution of this case by way of a negotiated settlement or Offer of Judgment by the Department of the Corporation Counsel, the Council wishes to authorize the settlement; now, therefore,

Resolution No.

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves settlement of the claim in the amount of Forty-five

Thousand Dollars (\$45,000);

2. That it authorizes the Mayor to execute a Release and Settlement

Agreement on behalf of the County in this case, under terms and conditions as

may be imposed by the Corporation Counsel consistent with the Council's

settlement approval;

3. That it authorizes the Director of Finance to satisfy settlement of

this case, under terms and conditions as may be imposed by the Corporation

Counsel consistent with the Council's settlement approval; and

4. That certified copies of this Resolution be transmitted to the Mayor,

Director of Finance, Director of Water Supply, and Corporation Counsel.
