A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI,
APPENDIX B, DEPARTMENT OF WATER SUPPLY,
WATER SERVICE RATES – AGRICULTURAL CONSUMERS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Ordinance No. 5528, Bill No. 22, CD1, FD2 (2023), as amended, "Fiscal Year 2024 Budget", Appendix B, Revenues – Fees, Rates, Assessments and Taxes, Department of Water Supply, Water Fund, Water Service Rates – Agricultural Consumers is amended to add a new category "Nondwelling Agricultural Rate" prior to Water Shortage Rates, to read as follows:
