 - b. Under what circumstances can HUD deny a reimbursement request?
 - c. What is the County's contingency plan if a reimbursement request is denied?

- 3. Would the Administration provide a refresher on the timelines for obligating and expending the CDBG-DR Grant funds?
 - Are there any risks or penalties if deadlines are not met? If a. so, please explain.
- What is the Administration's plan for managing all CDBG-DR 4. compliance, audit readiness, and financial reporting?
- 5. What is the status of other disaster recovery resources, such as FEMA Public Assistance, Hazard Mitigation funds, or insurance proceeds?
- 6. The CDBG-DR grant has repeatedly been described as the funder of last resort. How is "last resort" funding status determined?
 - Please provide an example of how a project would be funded a. and move forward. If helpful, Komohana Hale may serve as a reference, as insurance proceeds are expected to support its reconstruction.
