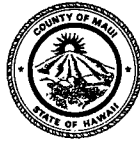

4. Relating to Budget Details, page 15-76, index code 910166C, sub-object code 7044, with a cost of \$250,000 for one unit, what has the department been using for this task, in the absence of a Situational Training & Response Simulator? (KK)
5. Relating to Budget Details, pages 15-77 and 15-78, index code 910190C, sub-object code 7040, provide a justification for requesting new vehicles, specifically 3 marked SUVs, 17 marked

patrol vehicles, 2 unmarked sedans, 1 unmarked SUV, and 1 unmarked patrol vehicle, totaling \$1.339M. (KK)
