**SUBJECT: AMENDMENT TO THE FISCAL YEAR 2019 BUDGET**

On behalf of the Department of Fire and Public Safety I am transmitting the attached proposed bills for the purpose of amending the Fiscal Year 2019 Budget by adding additional bond funded appropriations under Department of Finance, Countywide Equipment for equipment purchases under the Fire/Rescue Operations Program.

The department currently has a FY 2018 bond appropriation of \$1,000,000 for a ladder truck for the Wailea Fire Station and a FY 2019 bond appropriation of \$1,700,000 for one pumper truck each for the Kihei and Napili Fire Stations and a \$300,000 General Fund appropriation for one brush truck each for the Lahaina and Kahului Fire Stations.

A consolidated bid for all five trucks was received from Hughes Fire Equipment and is attached for your review. The consolidated bid offers considerable discounts if all five trucks are purchased together as well as a lower than anticipated price for the two pumper trucks. The ladder and brush trucks are priced higher than budgeted at \$1,347,000 and \$452,000, respectively.


The department is respectfully requesting that the \$1,000,000 bond appropriation from FY 2018 be re-appropriated to FY 2019 plus an additional \$351,000 so it may move forward with the purchase of all five trucks at a total cost of \$3,351,000.

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4858, Bill No. 54 (2018), is amended by  
amending Section 1 to read as follow:

SECTION 1. Authorization of General Obligation Bonds. Pursuant to Chapter 47, Hawaii Revised Statutes, as amended, and particularly Part I thereof, there are hereby authorized to be issued and sold from time to time general obligation bonds of the County of Maui, State of Hawaii (the "County") in an aggregate principal amount not to exceed [~~\$68,660,000~~] \$70,011,000 (the "Bonds"), the proceeds derived from the sale of which shall be used to pay all or part of the cost of appropriations for the public improvements of the County described in Section 2 hereof.

SECTION 2. Disposition of Bond Proceeds. All or any portion of the proceeds derived from the sale of the Bonds or any notes issued in anticipation of the Bonds shall be used to pay all or part of the cost of any of the public improvements listed below in accordance with appropriations contained in the Fiscal Year 2019 Budget, including amendments and supplements thereto, duly approved by the Council of the County (the "Council") for the fiscal year ending June 30, 2019 (the "Fiscal Year 2019 Budget"); provided, however, that pursuant to Section 47-5, Hawaii Revised Statutes, the part of such proceeds which are in excess of the amounts required for the purposes for which the Bonds are initially issued from time to time, or which may not be applied to such purposes, or which the Council deems should not be applied to such purposes, may be applied to finance such other public improvements of the County as the Council shall, by ordinance approved by an affirmative vote of two-thirds of all of its members, determine; and provided further that the actual use and application of the proceeds of Bonds issued pursuant to this ordinance shall not in any way affect the validity or legality of such Bonds. No proceeds of the Bonds shall be applied to any public improvement listed in this section unless and until there shall be a valid appropriation of general obligation bond proceeds in effect for such public improvement. The public improvements provided for or to be provided for in the Fiscal Year 2019 Budget, to be financed with proceeds from the sale of the Bonds, are as follows:

**Terms:**

Based on the current delivery schedule the units would be *ready for delivery from factory* within the time line listed below. Delivery is subject to change pending Manufacturer's delivery schedule at order placement. Once the apparatus is ready for shipment from the factory it will be delivered to a Hughes Fire facility for a PSI and any required dealer to furnish items, then transported to the dock in San Diego, CA for shipment to Maui, HI.

Pierce Arrow XT 107' Ascendant Aerial RH390: 8.5 - 15 months after order placement

Pierce Enforcer Pumpers SO203: 7.5-14 months after order placement

An invoice will be provided 30 days prior to the chassis payment due date if elected.

An invoice will be provided upon order processing for the 100% prepayment if elected.

If payment discount options are not elected standard payment terms will apply: Final payment will be due 30 days after the unit leaves the factory for delivery. If payment is not made at that time a late fee will be applicable.

Purchasing documents will be between Hughes Fire Equipment and the customer.

Transportation of the unit to be driven from the factory is included in the pricing. However, if we are unable to obtain necessary permits, due to the weight of the unit, and the unit must be transported on a flat bed, additional transportation charges will be the responsibility of the purchaser. We will provide pricing at that time if necessary.

Three (3) factory inspection trips for four (4) fire department representatives is included in the above pricing for the Pierce Arrow XT 107' Ascendant Aerial RH390. Three (3) factory inspection trips for four (4) fire department representatives is included in the above pricing for the two (2) Pierce Enforcer Pumpers SO203 units. One (1) Factory inspection trip for three (3) fire department representatives is included in the above pricing for the Ford F550 Skeeter Brush Trucks SO3867. The inspection trips will be scheduled at times mutually agreed upon between the manufacturer's representative and the customer. Airfare, lodging and meals while at the factory are included. If the Department elects to forgo an inspection trip \$1,850.00 per traveler (per trip) will be deducted from the final invoice.
