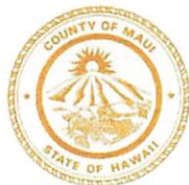

SUBJECT: **AMENDMENTS TO THE FISCAL YEAR 2026 BUDGET  
(APPENDIX A, PART I, DEPARTMENT OF 'ŌIWI  
RESOURCES, PRIVATE DONATIONS)**

On behalf of the Department of Ōiwi Resources, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET; APPENDIX A, PART I, DEPARTMENT OF 'ŌIWI RESOURCES, PRIVATE DONATIONS; NEW APPROPRIATION OF \$1,000."

The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget, Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, to add a new appropriation under the Department of 'Ōiwi Resources, entitled "Private Donations" in the amount of \$1,000.

2. A proposed resolution entitled "AUTHORIZING ACCEPTANCE OF A DONATION OF \$250 FROM C&S WHOLESALE GROCERS, LLC, THE DEPARTMENT OF 'ŌIWI RESOURCES, COUNTY OF MAUI, UNDER SECTION 3.56.030, MAUI COUNTY CODE."

The purpose of the proposed resolution is to authorize the acceptance of a donation of \$250 from C&S Wholesale Grocers, LLC.

These funds will be used to support a grant workshop in Central Maui in March 2026. The Department of 'Ōiwi Resources has applied with several possible funders to support the activities of the Department, therefore the donation amounts differ between the proposed amendment and the proposed resolution to accommodate similar funds received in the future. If additional donations are received, resolutions authorizing their acceptance will be submitted to Council.
