

Overall Sentiment








Dear Chair U'u-Hodgins, Vice-Chair Paltin and Members,

I am Tom Croly and I'd like to express my support for confirming Gina Young as Director of the East Maui regional water authority.

I first came to know Gina about 15 years ago when she was serving as the president of the Kula community association. I was so impressed to see how she was able to lead civil meetings of the association that often dealt with controversial issues. I think everyone knows there are some very outspoken upcountry residents, who can tend to dominate the public discussions, but Gina displayed a unique talent to encourage all to be heard and as a result the Kula Community association produced thoughtful positions on community issues like the Maui Island Plan, the Bed and Breakfast and STRH ordinances and multiple upcountry water issues.

Soon after that first meeting, I was pleased to see that Gina was being considered for a position in the planning department. At that time I was working closely with the planning department to help improve the permitting process for B&Bs. In a very short period of time, Gina had established herself as one of the lead planners in the department, who the other planners looked to for guidance when processing permits. I observed that when Gina was presenting a permit application before the planning commission, she would quickly gained the confidence of the commission members, because she was always prepared to answer any question they might have.

Over the past 17 years, I have worked directly with more than 20 different planners in the current planning division. I can say without question that during the time Gina was in the department there was much better consistency between how planners processed permits. I often would tell permit seekers, there are planners who are problem makers and planners who are problem solvers. Gina was a problem solver. This letter is given to provide testimony to the efficacy, enthusiastic and capable support given to initiatives which support Maui Hikina, and professional, sincere engagement, which I have had the privilege of receiving from Gina Young. As the Executive Director of the H_na Business Council (HBC), in my role as a businessperson, community advocate, and nonprofit director, two main initiatives in which I have seen Gina assist in orchestrating broader community outreach, bridging Maui County departmental leadership and resources, have been in the areas of Workforce Development and the current H_na Walking-Bikeway Plan.

As the Design Section Head for the State of Hawaii Department of Transportation (HDOT) Maui District, I am the person Gina and her office call for updates on local design projects, including Hana Highway. Gina has a great approach to problem solving and resolution. Her commitment to and familiarity with East Maui is commendable. Her personal skills and collaborative attitude will be an asset to the job. I have found her to be knowledgeable, polite, reasonable and understanding of the state's process, an attitude not all people exhibit.

I also know Gina personally from sailing as we crewed and raced on the same boat prior to the Lahaina fire. We both enjoy our public service work and have a great passion for sailing. We have spent many hours sailing and discussing the various aspects of our jobs and local issues. It is always a joy to learn about the inside workings of Maui County government from her. Gina's previous experience as the Planning Department Special Management Area (SMA) planner and understanding of SMA rules and regulations has also been useful. It is obvious that she loves working for Maui County government and takes pride in making our community a better place to live.

I find that the challenges of sailing can tell you a lot about a person. I know Gina to be a team player, a kind person, hardworking, humble, and most importantly she handles herself well under pressure. In one notable case, she volunteered for a difficult task and used her water skills to swim under our sailboat and dislodge a mooring ball line that had gotten wrapped around the bow and hull keel. It is not easy to impress a crew of salty lifelong sailors, but she did just that and shrugged it off casually (we were all very impressed).

In another race, she showed herself to be a valuable team member and hearty sailor. After the Lahaina fire, various yacht clubs on Oahu sponsored a sailing race fund raiser for the Lahaina Yacht Club (LYC) employees. Gina and I, along with a couple of other members represented the LYC and participated in the Waikiki to Kaneohe Bay race. For portions of the race, we experienced high winds (20+ knots) and large swells (15-20 feet). At one point, our captain was caught off guard tossing the entire crew all over the boat with one crew

member going overboard. We were able to retrieve the man overboard as he slid along the outside of the boat lifeline. Gina kept her composure while we got the boat back under control. She went down below to help some of the spooked crew members then returned to take her position and continue sailing. Fortunately, this experience did not phase Gina as she worked alongside with the more experienced crew to finish the race. This experience showed her grit, calm and collected personality, ability to process information in a tense situation and be of value to a team. I know these skills will be useful in her new appointment and that she will set a tone of working in a collaborative and professional manner that benefits everyone and the community.
