Chair and Members:

Your Policy, Economic Development, and Agriculture Committee, having met on February 13, 2017, and March 6, 2017, makes reference to County Communication 17-7, from Council Chair Mike White, relating to nominations to boards, committees, and commissions.

By correspondence dated and received January 30, 2017, the Mayor transmitted the following:

Your Committee notes general appointment procedures for boards and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code (MCC).

Your Committee further notes specific provisions for these boards are as follows:

- 1. Kula Agricultural Park Committee: Sections 2.40.180 and 22.04A.070, MCC;
- 2. Maui Redevelopment Agency: Section 2.40.050, MCC, and Section 53-2, Hawaii Revised Statutes; and
- 3. Urban Design Review Board: Chapter 2.26 and Section 2.40.100, MCC.

Your Committee further notes there is no time limitation for Council to approve or disapprove the nominations.

Your Committee did not request to interview the nominees.

A representative of the Mayor spoke to the merits of the nominees and assured your Committee of their availability to attend scheduled meetings.

In discussing the Kula Agricultural Park Committee nominees, your Committee was concerned small farmers and organic (natural) farmers from organizations such as Hawaii Organic Farming Association and Hawaii Farmers Union United were not being represented.

Your Committee recommended deferral of the nominations of Jamie Davidson (General Public) and Brandon Shim (Farm Bureau Representative) to the Kula Agricultural Park Committee.

By correspondence dated February 22, 2017, the Mayor transmitted a letter relating to the withdrawal of nominee Reid Kawabata to the Maui Redevelopment Agency due to personal circumstances. Your Committee recommended Exhibit "C", Disapproved Members, to the proposed resolution be revised accordingly.

Your Committee was satisfied with the nominees' applications to the Urban Design Review Board and expressed its gratitude to the nominees for volunteering to serve the community. Your Committee recommended Exhibit "B", Approved Members and Terms, to the proposed resolution be revised accordingly.

Your Committee voted 8-0 to recommend disapproval of the nomination of Reid Kawabata to the Maui Redevelopment Agency. Committee Chair Sugimura, Vice-Chair Crivello, and members Atay, Cochran, Guzman, Hokama, King, and White voted "aye." Committee member Carroll was excused.
