URGING THE DEPARTMENT OF PUBLIC WORKS TO INSTALL SIGNAGE RECOGNIZING WAILUKU RIVER

WHEREAS, the Council adopted Resolution 15-41 on April 7, 2015, entitled "URGING THE HAWAII STATE BOARD ON GEOGRAPHIC NAMES TO RENAME IAO STREAM TO WAILUKU RIVER"; and

WHEREAS, the Hawaii State Board on Geographic Names and the United States Board of Geographic Names subsequently agreed the correct name for the tributary on Maui previously known as Iao Stream is Wailuku River; and

WHEREAS, signage recognizing Wailuku River and informing the public of the proper name is desired;

WHEREAS, signage should be installed at the following locations in Wailuku, Maui, Hawaii: the entrance to Kepaniwai Park; North Market Street between its intersection with Kahawai Street and Liko Place, and Waiehu Beach Road between Eha Street and Kuhio Place; and

WHEREAS, the Department of Public Works is best situated to install such signage, in coordination with any other agencies as necessary; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it urges the Department of Public Works to install signage recognizing the name of Wailuku River at the entrance to Kepaniwai Park; North Market Street between its intersection with Kahawai Street and Liko Place, and Waiehu Beach Road between Eha Street and Kuhio Place; and
2. That certified copies be transmitted to the Mayor, the Director of Public Works, and the Director of Water Supply.
