A BILL FOR AN ORDINANCE AMENDING SECTION 2.08.060, MAUI COUNTY CODE, TO REVISE THE PAY PLAN IN THE OFFICE OF COUNCIL SERVICES

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. This Ordinance's purpose is to revise the Office of Council Services' pay plan to recognize the position of Council Services Ambassador and to place the position of Project Assignment Specialist under the CR-1 pay range.

SECTION 2. Section 2.08.060, Maui County Code, is amended by amending Subsection A to read as follows:

"A. The following pay plan is established:


