Dear Chair U'u -Hodgins:

This is in response to your request of August 22, 2025, for a legal opinion.

1. Ordinance 5779 (2025) became effective on March 11, 2025. Please explain how the Department is applying Ordinance 5779 (2025).

RESPONSE: The department is applying the ordinance to those vacancies that occurred prior to the establishment of the Independent Nomination Board (INB), no list was ever provided, and the Mayor is the appointing authority. Therefore, the requirement in section 2.41.050(A), to provide a list was never triggered. The effective date of the ordinance amending this code section was March 11, 2025. Meaning, that the Council could make unilateral appointments until April 10, 2025, which was the 30-day deadline. If the Council did not fill those vacancies, then the Mayor's office had thirty days to appoint a member. Since no names were submitted within that period, then the thirty-day deadline went back to the Council and then alternated between Council and the Mayor. The deadlines for all vacancies that occurred prior to the establishment of the INB should be the same.

2. Please provide the Department's counting mechanism used to fill vacancies under Charter Sections 13-2(17), 13-2(18), and 13-2(19).

RESPONSE:

The deadlines were calculated on 30-day intervals, and if the last day was a Sunday or a holiday, then it was extended to the next business day. Please see attached chart for dates up to December 2025. In this calculation it did not matter whether the vacancies occurred due to a mass nomination (that occurred prior to INB establishment) or death, resignation or termination, so the calculation is the same for both 13-2(17) or (18).

If a deadline under Charter Section 13-2(17) and 13-2(18) passed, then the deadline under Section 13-2(19) applies. If the appointing authority misses their deadline under 13-2(19), then the deadlines under Ordinance 5779 applies.

The deadline under Charter Section 13-2(19) had already passed for these vacancies, and therefore the deadlines under Ordinance 5779 was applied.
