A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5528, Bill No. 22, CD1, FD2 (2023), as amended, "Fiscal Year 2024 Budget", Section 3.B.6.d, Department of Fire and Public Safety, Fire Prevention Program, is amended to reduce Category B – Operations & Equipment and Total by \$50,000 and to add a new appropriation entitled "Transfer to the Fire Hazard Removal Revolving Fund" in the amount of \$50,000, to read as follows:
