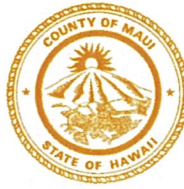


WHEREAS, Section 13-2 of the Charter requires the Mayor's nominees to be approved by the Council; and
