

# Resolution

ACTING ON THE NOMINATIONS OF LINDA PUPPOLO AND  
FRANK BARBOSA, JR. TO THE MAUI COUNTY COMMISSION  
ON PERSONS WITH DISABILITIES

WHEREAS, the Maui County Commission on Persons with Disabilities was formed and operates with nine members under Sections 2.32.020 and 2.32.030, Maui County Code; and

WHEREAS, two vacancies will occur on the Maui County Commission on Persons with Disabilities when existing terms expire on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr., notified the Council he nominated Linda Puppolo and Frank Barbosa, Jr., listed in Exhibit "A," as attached, to fill the vacancies; and

WHEREAS, the nominations are made in accordance with Sections 2.32.020 and 2.32.030, Maui County Code, and Sections 13-2, Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the nominations within 30 days after the Mayor submits the names of the nominees to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now, therefore,

**BE IT RESOLVED** by the Council of the County of Maui:

1. That it approves the appointments of the persons listed in Exhibit "B," to the Maui County Commission on Persons with Disabilities for the terms expiring on March 31, 2031;
2. That it hereby disapproves the appointment of the persons listed in Exhibit "C," as attached, as members to the Maui County Commission on Persons with Disabilities as nominated by the Mayor;
3. That the Council expresses its gratitude and appreciation to the nominees for their willingness to be considered for public service and actively participate in County government; and
