Chair and Members:

Your Disaster, Resilience, International Affairs, and Planning Committee, having met on June 17, 2024, makes reference to Resolution 24-101, entitled “AUTHORIZING ACCEPTANCE OF THE DONATION OF JET SKIS AND TRAILERS TO THE DEPARTMENT OF FIRE AND PUBLIC SAFETY, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE.”

Resolution 24-101’s purpose is to accept a donation of equipment from Lochland Holdings, LLC, for the Department of Fire and Public Safety, under Chapter 3.56, Maui County Code, as follows:

- Two Honda Aqua Trax F-15 jet skis
- One CSMITH 12-foot Smith Trailer
- One WCE-1250/900-40 Karavan Trailer

Your Committee notes Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County. The total estimated value of the donation is \$10,000.

Your Committee received a presentation from the Fire Chief. The Chief said the equipment is “gently used,” but in great condition. The Department conducted a sea trial and an evaluation of the equipment was performed by a third-party mechanic. Both evaluations found no issues.

The Chief further noted that the jet skis will be converted into rescue watercrafts. The jet skis will be used in the Department's training program.

Your Committee acknowledged Lochland Holdings, LLC, for the donation and cited the benefits of expanding the Department's training equipment while providing cost savings to the County.

Your Committee voted 5-0 to recommend adoption of Resolution 24-101. Committee Chair Paltin and members Cook, Rawlins-Fernandez, Sinenci, and Sugimura voted "aye." Committee Vice-Chair U'u-Hodgins and member Kama were excused.

Your Committee is in receipt of Resolution 24-101, CD1, entitled, "AUTHORIZING ACCEPTANCE OF THE DONATION OF JET SKIS AND TRAILERS TO THE DEPARTMENT OF FIRE AND PUBLIC SAFETY UNDER CHAPTER 3.56, MAUI COUNTY CODE," approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions.


