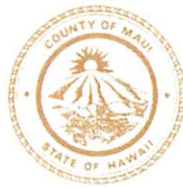

- 2) **Project Name:** Paia Force Main
- 3) **Purpose:** For Underground Sewerline Purposes, including Manholes and other equipment and appurtenance necessary or expedient for the proper maintenance, operation or repair of such underground sewer pipelines.
- 4) **Dedication:** Sewer system improvements consisting of an existing 10-inch Ductile Iron Pipe sewerline installed in approximately 1983. All of the sewer system improvements have been confirmed to be located within stated easement areas.
- 5) **Conformance:** Easement locations and widths are acceptable to the Department of Environmental Management and are in conformance with County standards.

(10-FEET WIDE)**

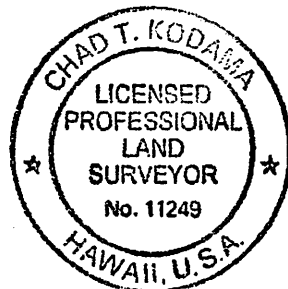
Being a portion of Baldwin Beach Park, also being a portion of land deeded by the Board of Education to the Trustees of the Oahu College dated January 30, 1860.

Land situated at Hamakuapoko, Maui, Hawaii

Beginning at the West corner of this piece of land, on the North side of Hana Highway (Paia Spur), N.R.S.H. 17-A, from Junction of New Puunene Road with Haleakala Road (F.A.P. 5-C) to lower Paia Village, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU NENE 2" being 4,867.67 feet North and 1,613.48 feet East, thence running by azimuths measured clockwise from true South:

8. 66° 33' 83.85 feet along the North side of Hana Highway (Paia Spur), N.R.S.H. 17-A, from Junction of New Puunene Road with Haleakala Road (F.A.P. 5-C) to Lower Paia Village to the point of beginning and containing an area of 4,614 square feet or 0.106 acre.

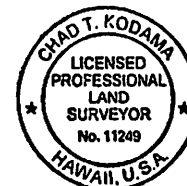

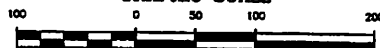
