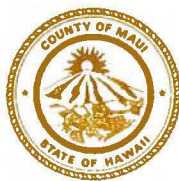
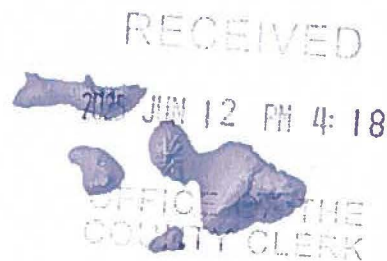

I'm interested in being a member of the Maui County Planning Commission because I am passionate about sustainable development and preserving the unique cultural and natural resources of Maui. I believe that thoughtful planning can balance growth with environmental stewardship, ensuring a vibrant community for future generations.

I'm not currently serving in any federal, state, or county capacity.

I help serve every week at my local church King's in Kahului. I lead a team that assists in teaching classes in business, marriage, parenting, biblical foundations and much more. We organize the food and fellowship weekly in addition to creating special events with guest speakers.

One of our recent events provided an encouraging word from a well-known and influential businessman from Australia and encouraged over 250 business owners in Maui with 35 continuing in a 7-week business scaling course at no cost to the local community.

My background as a retired military intelligence officer provides me with the discipline, knowledge and skills to be a great asset to the Planning Commission Committee. Since moving to Maui nearly 20 years ago, I have built several businesses and have been active in the retail, agriculture and business communities.

My skillsets include how to build teams, manage time effectively in meetings, execute tasks expeditiously, listen intently to the concerns of others while working with them to provide an immediate solution, work within budget and time constraints on large scale projects.

In the last twenty years, I have managed financial portfolios up to \$120 million in assets and have managed up to 300 employees at any given time. I have held a Top Secret Security Clearance for the majority of my 24 year career with the military which enabled me to work with cutting edge technology, highly educated and intellectual minds to provide solutions to incredibly complex problems and network with security agencies to include the FBI, NSA, CIA and foreign military aides.

I am currently the Senior Executive Vice President of an Independent Marketing Organization called Exertus Financial Partners. The financial constraints on the local community, businesses and therefore resulting in a tighter budget for the county will give me a challenge that I am excited to take on when it comes to future planning.
