Chair and Members:

Your Budget, Finance, and Economic Development Committee, having met on September 5, 2025, makes reference to the following:

Bill 100 (2025), entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET; INCREASE ESTIMATED REVENUES, OTHER INTERGOVERNMENTAL CAPITAL IMPROVEMENT \$750,000: PROJECTS. DEPARTMENT OF WATER SUPPLY, COUNTYWIDE, AND APPENDIX C, DEPARTMENT OF WATER SUPPLY, COUNTYWIDE, COUNTYWIDE **UPGRADES** AND REPLACEMENTS, INCREASE **APPROPRIATION** BY \$750,000."

Bill 100's purpose is to amend the Fiscal Year 2026 Budget, by: 1) increasing Other Intergovernmental estimated revenues by \$750,000; 2) increasing the Department of Water Supply's appropriation for Countywide Upgrades and Replacements under the State Revolving Loan Fund by \$750,000; 3) amending Appendix C – Capital Improvement Projects, Department of Water Supply, Countywide Upgrades and Replacements by \$750,000; and 4) adjusting the totals accordingly.

2. Bill 101 (2025), entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE 5821, BILL NO. 46, FD1 (2025), RELATING TO AN INTERGOVERNMENTAL AGREEMENT FOR A LOAN FROM THE STATE OF HAWAII'S WATER POLLUTION CONTROL REVOLVING FUND FOR VARIOUS WATER SUPPLY PROJECTS, FISCAL YEAR 2026 BUDGET ORDINANCE."

Bill 101's purpose is to amend Ordinance 5821 (2025) by authorizing the Mayor to increase the State Revolving Fund loan for Countywide Upgrades and Replacements by \$750,000, to finance granular activated carbon filter replacements at the Napili and Honokahua Wellfield.

Your Committee notes that under Section 2.20.020, Maui County Code, the Mayor must not enter into an intergovernmental agreement that creates a financial obligation for the County unless authorized by ordinance.

The Director of Water Supply said that the filter-replacement project is in the FY 2026 Budget. He explained that bids came in higher than estimated, which requires additional funding. He said the project is necessary to protect water quality and maintain service reliability, while aiding in the system's efficiency.

Your Committee notes that the State approved the funding increase through the Drinking Water State Revolving Fund, which provides a cost-effective way to finance the filter replacements.

Your Committee voted 8-0 to recommend passage of Bills 100 (2025) and 101 (2025), on first reading. Committee Chair Sugimura, Vice-Chair Kama, and members Cook, Johnson, Paltin, Rawlins-Fernandez, Sinenci, and U'u-Hodgins voted "aye." Committee member Lee was excused.

#### BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5821, Bill 46, CD1 (2025) is amended by amending Section 1 to read as follows:

"SECTION 1. Request for Loan. The County of Maui, under Section 342D-83 through Section 342D-87, Hawaii Revised Statutes, may submit applications for State Water Pollution Control Revolving Fund Loans ("SRF loans") to the Director of the Department of Health, State of Hawaii, to finance the following project:

a. Countywide Upgrades and Replacements \$[3,000,000] 3,750,000

Total \$[3,000,000] 3,750,000

("Project").

Under the terms and conditions anticipated for each SRF loan, the County must repay, over a term of twenty years, the principal amount, which must not exceed the amount of each loan stated above, at a fixed rate of interest that must not exceed the Bond Buyer's 20-year general obligation bond issue."
