PLASTIC BAG REDUCTION (IEM-56)

Description: The Committee is in receipt of the following:

1. County Communication 16-62, from Councilmember Elle Cochran, relating to a proposed bill on plastic bag reduction.
2. Correspondence dated October 25, 2016, from Councilmember Elle Cochran, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 20.18, MAUI COUNTY CODE, RELATING TO PLASTIC BAG REDUCTION." The purpose of the revised proposed bill is to: 1) simplify and strengthen the definitions of "Plastic bag" and "Reusable bag"; 2) exempt plastic bags used for specified purposes from the plastic bag prohibition; 3) repeal the requirement for annual reporting by the Department of Environmental Management starting in 2018; and 4) prohibit businesses from providing prohibited plastic bags to their customers at any time, not just at the point-of-sale.

Status: The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 16-62 and other related action.
