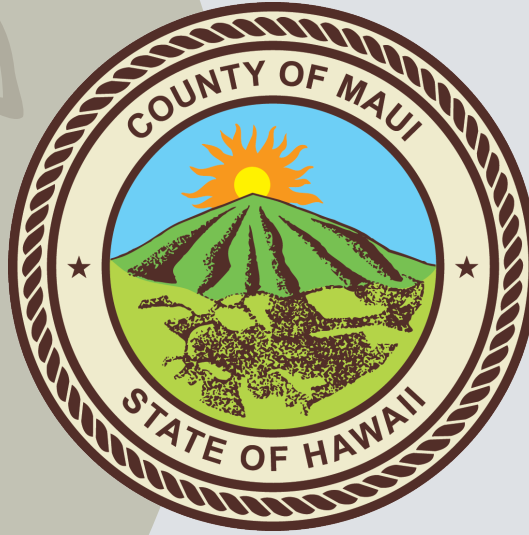

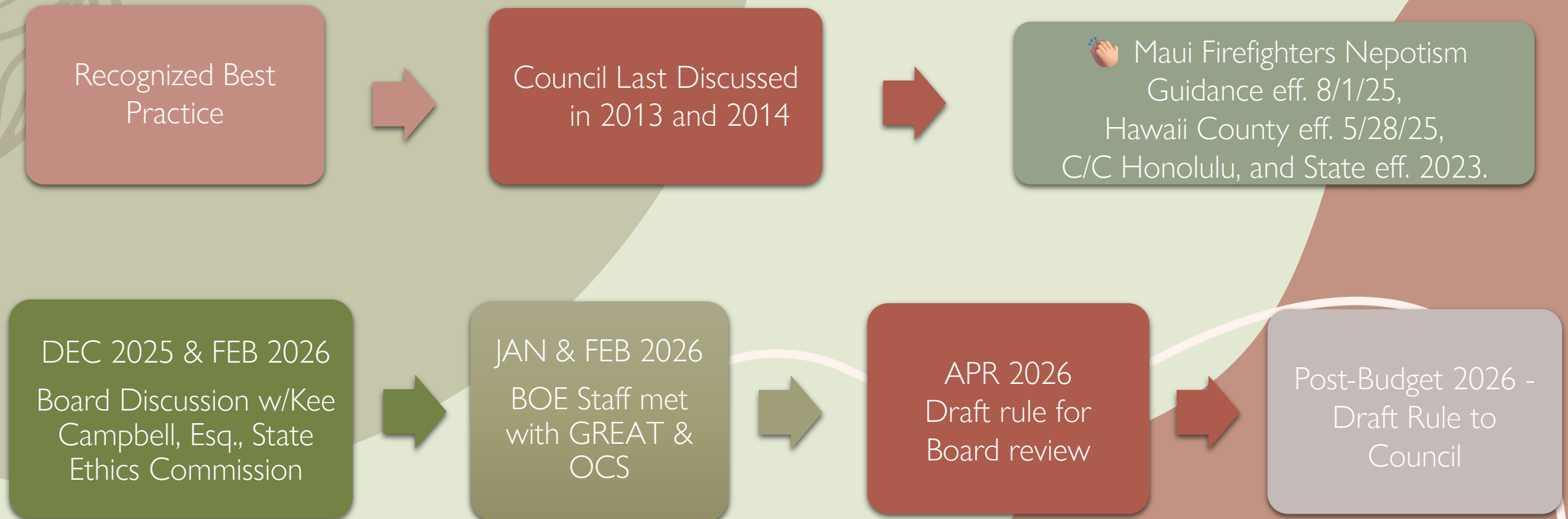

Countywide Nepotism Rule



“Lobbyist”

means any person who engages himself or herself for pay or other consideration for the purpose of attempting to influence legislative or administrative action of the County. Rule §04-101-3

Comprehensive Rules
E.g. - Lobbyist Expenditure Report

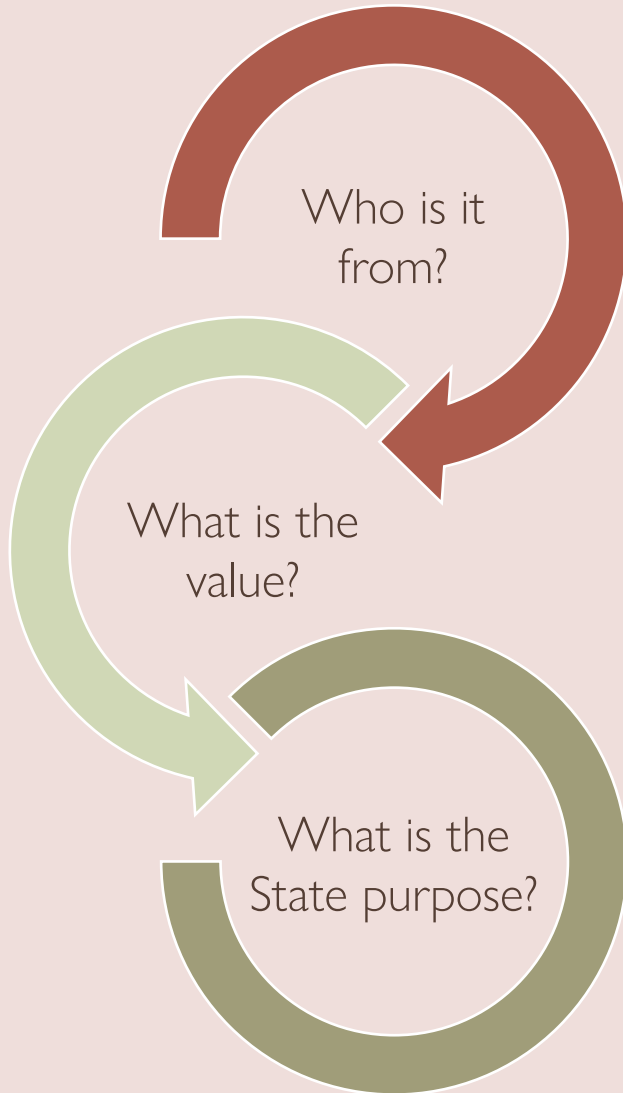

Current rule – Charter Article 10, Section 10-4.1.a

Reasonably be inferred .. intended ... to influence .. or reward.

FDS Disclosure – aggregate \$50+ from a single source

MCC § 04-101-142(a)(9)

\$25 “Gifts of Aloha” is not our rule.

State’s experience: set dollar amount leads to abuses.

Gift Permitted Interaction Group formed

Considering adopting the State’s rule – 3-part test (2020)

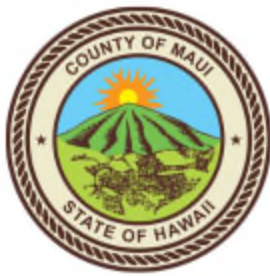
