Background Data: At the October 20, 2025, Water Authority, Social Services, and Parks Committee meeting, the Committee and the Honolulu Police Department's representative referenced Chapter 11-46, Hawai'i Administrative Rules, and Sections 291-24 and 291-24.5, Hawai'i Revised Statutes, which governs noise in residential, commercial, and industrial spaces and mufflers, respectively. May I please request you explain whether these State laws preempt Sections 9.36.030, 9.36.040, and 10.20.440, Maui County Code.
