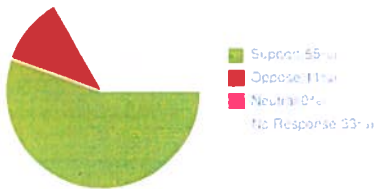

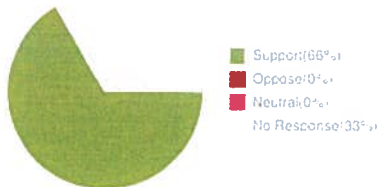

Last year when the Mayor requested his budget proposals, I requested \$800,000 on behalf of the USA Pickleball Association. We would like to see a state of the art 12 court facility built at Maui Lani Regional Park on Maui Lani Parkway (or another Wailuku park). Maui Lani Regional Park would be an ideal spot for pickleball courts because it is not close to any homes and would not disturb residents. This is a very large plot of land which sits unused on many days. A 12 court facility would only use a fraction of this large park. Central Maui desperately needs dedicated pickleball courts constructed. The courts could be open air with a roof covering. (meaning they would have no walls, but would have a roof covering to keep out the sun and rain. The roof would allow for play 100% of the time. Currently the only place to play when it rains is the Eddie tam gym, which is only open 2 hours per week on Wednesday mornings and is too far away from the central Maui players. 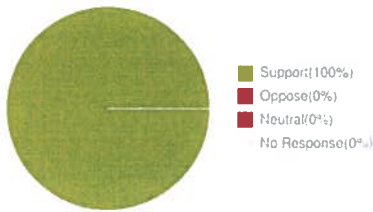

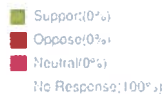

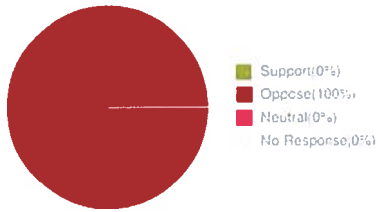

Aloha Chair Rawlins-Fernandez, Vice Chair Paltin, and Councilmembers:

Mahalo for allowing Pūlama Lānaʻi the opportunity to share our thoughts with you on the agenda item: Bill 68 (2022), Creating a managed retreat revolving fund (BFED-106).

The purpose of proposed Bill 68 (2022) is to establish a new Chapter 3.97, Maui County Code, creating a managed retreat revolving fund for optimizing opportunities for shifting development inland from the coast through the physical movement of existing structures by funding shoreline safety improvements; removal or relocation of structures; studies, programs and permitting; and leveraging funds provided by federal, state, nonprofit or for-profit organization, and other non-County entities.

Pūlama Lānaʻi would like to offer the following comments for consideration to proposed Bill 68 (2022).

Transient Accommodations Tax ("TAT")¹ paid by Lānaʻi entities to be set aside for Lānaʻi island
Pūlama Lānaʻi applauds the Council for being proactive in addressing the lack of funding regarding the impacts of climate change by creating a managed retreat revolving fund. We would encourage the Council to consider setting aside the TAT revenues provided by Lānaʻi entities to benefit the impacts of climate change on Lānaʻi by setting up a separate account within the managed retreat revolving fund dedicated for Lānaʻi. This will ensure that there is a minimal amount of funding available for Lānaʻi, which would benefit the residents of Lānaʻi, today and into the future. The Council, per proposed Bill 68 (2022)² would have the ability to appropriate more funds for Lānaʻi, if necessary; however, the consideration is for a minimal amount paid by Lānaʻi entities to benefit Lānaʻi for generations.

The TAT in the Mayor's proposed budget accounts for 5.7 percent of the sources of funding for FY 2023.³ Proposed Bill 68 (2022), is requested that one-third be allocated for the managed retreat revolving fund.⁴ Lānaʻi is home to two world renowned resorts, which would contribute TAT to the managed retreat revolving fund. The impacts from the transient accommodations should benefit the areas where the accommodations exist, at minimum.

For the benefit of the Lānaʻi community, Pūlama Lānaʻi suggests the following language for consideration by the Council to proposed Bill 68 (2022) (suggested language underlined).

3.97.030 Deposits to the revolving fund. A. There will be deposited into the managed retreat revolving fund:

1. One-third of the Maui County transient accommodations tax collected pursuant to chapter 3.47.
 - a. Revenue from transient accommodations tax collected from Lānaʻi must be incurred by expenditures for Lānaʻi.
2. Revenue from any applicable fees set in the annual budget ordinance.
3. Supplemental transfers set in the annual budget ordinance.
4. Revenue from any applicable grants or programs.

3.97.040 Administration. A. The director of finance must establish a separate account to record revenues and supplemental transfers credited to and expenses incurred by the fund.

1. The director of finance must establish a separate account to record revenues and supplemental transfers credited to and expenses incurred by the fund for Lānaʻi.

B. Any proposed appropriation will be submitted to the council for approval as a budget appropriation in either the annual budget ordinance or a proposed amendment to the annual budget ordinance. In adopting each fiscal year's budget and capital program, the council may make appropriations to the fund.

C. Any unencumbered balance at the end of each fiscal year shall not lapse but shall remain in the fund, accumulating from year to year.

D. The department of planning shall administer the fund.

E. The director of finance and planning director may adopt administrative rules necessary to carry out the purposes of this chapter.
