RESOLUTION 25-49, AUTHORIZING THE ACQUISITION OF LAND AT LIMAHANA PLACE, LAHAINA, MAUI

Description: The Committee is in receipt of Resolution 25-49, entitled "AUTHORIZING THE ACQUISITION OF APPROXIMATELY 24.018 SQUARE IDENTIFIED AS TAX MAP KEY NO. (2) 4-5-007-028 SITUATED AT FOR AN AMOUNT LAHAINA, MAUI, HAWAII, NOT TO EXCEED \$1,700,000.00." Resolution 25-49's purpose is authorize acquisition of land at 968 Limahana Place, Lahaina, Maui, Hawai'i, consisting of approximately 24,018 square feet identified at tax map key (2) 4-5-007:028, for an amount not to exceed \$1,700,000, plus closing costs and expenses.

BILL 103 (2024), AMENDING CHAPTER 19.08, MAUI COUNTY CODE, RELATING TO DENSITY WITHIN RESIDENTIAL DISTRICTS

<u>Description:</u> The Committee is in receipt of the following:

- Bill 103 (2024), entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.08, MAUI COUNTY CODE, RELATING TO DENSITY WITHIN RESIDENTIAL DISTRICTS." Bill 103's purpose is to increase the allowable density in the R-1, R-2, and R-3 Residential Zoning Districts to provide additional housing opportunities in Maui County.
- Correspondence dated June 27, 2024, from the Planning Director, transmitting the Department of Planning's report and recommendations from the Lāna'i, Maui, and Molokai planning commissions and related documents.
- 3. An Amendment Summary Form, dated February 12, 2025, from the Committee Chair, with a proposed CD1 version of Bill 103 (2024), entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.08, MAUI COUNTY CODE, RELATING TO DWELLING TYPES AND DENSITY WITHIN RESIDENTIAL DISTRICTS." The proposed CD1 version: 1) amends the bill's title; 2) amends Section 19.08.020, Maui County Code, for consistency with the dwelling types inserted into the table of development standards under Section 19.08.040, Maui County Code; and 3) incorporates nonsubstantive and technical revisions for clarity, consistency, and style.

BILL 104 (2024), AMENDING CHAPTERS 19.04, 19.08, AND 19.29, MAUI COUNTY CODE, RELATING TO KITCHENS, KITCHENETTES, AND WET BARS; AND SECTION 19.36B.020, MAUI COUNTY CODE, TO ADD PARKING REQUIREMENTS FOR DWELLING UNITS WITH KITCHENETTES

<u>Description:</u> The Committee is in receipt of the following:

- 1. Bill 104 (2024), entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTERS 19.04, 19.08, AND 19.29, MAUI COUNTY CODE, ADDING A NEW DEFINITION AND USE FOR KITCHENETTE AND AMENDING THE EXISTING DEFINITIONS OF DWELLING UNIT AND WET BAR, AND AMENDING SECTION 19.36B.020 TO **ADD** PARKING REQUIREMENTS FOR KITCHENETTES." Bill 104's purpose is to provide lower-cost opportunities for more autonomous living areas in a dwelling unit by amending the Comprehensive Zoning Ordinance to: 1) allow for kitchenettes in dwelling units in the Residential and Rural Districts on Maui and Lāna'i; and 2) require a dwelling unit with a kitchenette to be occupied on a long-term residential basis, with one additional off-street parking space to accommodate the higher intensity use for each kitchenette. also makes conforming amendments to the definitions of "kitchen" and "wet bar."
- 2. An Amendment Summary Form, dated November 14, 2024, from the Housing and Land Use Committee Chair (2023-2025 Council term), with a proposed CD1 version of Bill 104 (2024), entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTERS 19.04, 19.08, 19.29, AND COUNTY RELATING 19.36B, MAUI CODE. TO KITCHENS, KITCHENETTES, AND WET BARS." The proposed CD1 version: incorporates clarifying revisions to the bill's title and purpose statement; 2) removes the requirements for dwelling units with kitchenettes to be occupied on a long-term residential basis and to have one additional off-street parking space for each kitchenette from and inserts the requirements the definition of "kitchenette" Chapters 19.08 and 19.29; and 3) incorporates technical and nonsubstantive revisions.
- 3. An informational document, dated November 20, 2024, from the Housing and Land Use Committee Chair (2023-2025 Council term), with proposed amendments to the proposed CD1 version of Bill 104 (2024), to accommodate the Department of Planning's proposed amendments relating to the definition of "kitchenette."

Status: The Committee may consider whether to recommend passage of Bill 104 (2024) on first reading, with or without revisions. The Committee may also consider the filing of Bill 104 (2024) and other related action.
