SUBJECT: **WEST MAUI COMMUNITY PLAN** (PSLU-1)

The Planning and Sustainable Land Use Committee is requesting your feedback on adding language to Policy 2.1.8 of the Draft West Maui Community Plan relating to retrofitting existing buildings that currently serve as emergency shelters to comply with hurricane shelter standards.

Please find attached correspondence dated February 11, 2021, and March 23, 2021, requesting your input.

In addition, it was mentioned at the February 18, 2021 Human Concerns and Parks Committee meeting that the War Memorial Complex is slated for capital improvements to make the structure a Category 3-rated shelter under Enhanced Hurricane Protection Area ("EHPA") standards.

May I request that you also address the following:

1. Is EHPA the current standard in Maui County for existing and retrofitting hurricane shelters? If not, what is the standard used in Maui County?
2. What factors determine whether a structure should be built or retrofitted to meet EHPA standards?

May I request you submit your response by **June 14, 2021**. As the Committee continues to discuss changes to the Plan, it is important that we receive your feedback in a timely manner.

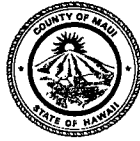

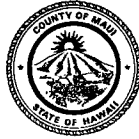

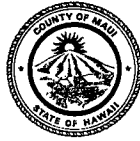
