WHEREAS, by correspondence dated March 20, 2019, Mayor Michael P. Victorino notified the Council that he nominated William Cambra to the Real Property Tax Review Board for the County of Maui for a term expiring March 31, 2023, to fill a vacancy replacing Michael Gurat, pursuant to Sections 2.40.170 and 3.48.620, Maui County Code ("MCC"), and Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and


WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Section 13-2(17), Charter, requires the Council to approve or disapprove the nominee within sixty (60) days after the Mayor submits the nominee to the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of William Cambra to serve on the Real Property Tax Review Board for a term expiring March 31, 2023; and
2. That the Council expresses its gratitude and appreciation to William Cambra for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
