APPROVING A TIME EXTENSION FOR THE COUNCIL TO ENACT THE LANAI COMMUNITY PLAN

WHEREAS, Section 2.80B.090(D), Maui County Code, provides as follows:

“D. No later than one year after receipt of a transmittal pursuant to subsection C, the council shall adopt the community plan by ordinance following a public hearing in the community plan area. The council may, by resolution, extend the time within which the ordinance must be enacted.”; and

WHEREAS, on November 21, 2014, the County Council received from the Planning Director, County Communication 14-283, transmitting a proposed bill to adopt the decennial revisions to the Lanai Community Plan and other related documents; and

WHEREAS, on November 6, 2015, the Council adopted Resolution No. 15-140, extending the time within which the Council shall enact the Lanai Community Plan to March 15, 2016; and

WHEREAS, on February 5, 2016, the Council adopted Resolution No. 16-10, extending the time within which the Council shall enact the Lanai Community Plan to April 29, 2016; and

WHEREAS, the Council requires additional time to complete its review of the Lanai Community Plan; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That the time within which the County Council shall enact the Lanai Community Plan by ordinance be extended to June 30, 2016; and
2. That certified copies of this resolution be transmitted to the Mayor, the Planning Director, and the Corporation Counsel.
