A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.40, MAUI COUNTY CODE, TO RENAME KULA COMMUNITY CENTER TO VON TEMPSKY 'OHANA COMMUNITY CENTER COMPLEX

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Chapter 12.40, Maui County Code, is amended by adding a new section to be appropriately designated and to read as follows:

**“12.40.300 Von Tempsky ‘Ohana Community Center Complex. Von Tempsky ‘Ohana Community Center Complex refers to the area formerly known as Kula Community Center, identified as TMK: (2) 2-3-037:026 and located at 4355 Lower Kula Road, Kula, Hawai‘i.”**

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include underscoring.

SECTION 3. This Ordinance takes effect on approval.
