SUBJECT: NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS

(ANIMAL CONTROL BOARD) (PEA-2(2))

Section 13-2, Revised Charter of the County of Maui (1983), as amended. and Chapter 2.41, Maui County Code ("MCC"), outline the procedure for both the Mayor and the Council to follow in the event of a vacancy on a board, committee, or commission.

There is one vacancy on the Animal Control Board for a term expiring on March 31, 2018, due to the resignation of Larry Shapiro on January 19, 2017. The Mayor did not submit his nominee to the Council within 30 days of the occurrence of the vacancy caused by Mr. Shapiro's resignation.

The Council now has 60 days to nominate and approve the appointment of an individual to fill this vacancy. The Council's deadline to take action is April 19, 2017.

Section 2.41.050(B), MCC, states: "Any member of the council may nominate one individual per vacancy by transmitting the information required under section 2.41.020 to the council or appropriate council committee." The information required by Section 2.41.020, MCC, when nominating an individual to a board, commission, or committee is included on the attached application forms.

If you would like to nominate an individual to fill a vacancy on the Animal Control Board, please transmit a completed Council application form to the PEA Committee no later than 4:00 p.m. on Wednesday, March 8, 2017, to meet the Committee's internal posting deadline on March 14, 2017.
