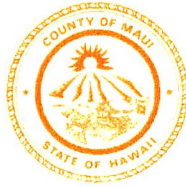
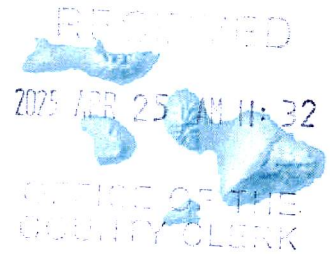



I am transmitting a proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, GRANTS AND DISBURSEMENTS FOR WATER AND ENVIRONMENTAL RESOURCE PROTECTION, DEPARTMENT OF MANAGEMENT, OFFICE OF RECOVERY PROGRAM."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget to delete the appropriation for the Trust for Public Land for due diligence on

properties in Ma'alea in the amount of \$100,000, and add a new appropriation under Department of Management, Office of Recovery for assistance with property acquisition in West Maui, in the amount of \$100,000.

The Trust for Public Land will no longer be able to assist the County with due diligence on properties in Ma'alaea, so the Administration is proposing this amendment to instead use the funds for assistance with property acquisition in West Maui.
