

Overall Sentiment









My name is Mavis Oliveira-Medeiros and I'm an employee of Councilmember Shane Sinenci. I'm writing in support of BFED-78 CC 21-29. I've lived in Hana most of our lives and have watched as families upon families lose their aina because of property taxes they can no longer afford. It's very sad to watch and not be able to help because many times, their tax bill has gone up in the thousands and thousands of dollars. Tens and Hundreds of thousands for some. I can name the families who have lost or are close to losing their family aina. They don't qualify for "Kuleana taxes" but have been on the aina for gennerations.

My maternal side ohana also have aina that have gone up recently and even though there's a "fund" for collecting monies to pay the taxes, it has been hard to keep up. My Mom's ohana have been on the aina for many generations since the 1800's. Many are resting on the lands now owned by the State Department of Land and Natural Resources. This is where the Waianapanapa State Park and Cabins are located. My great great Tutu Ahukiniala'a Kahanaole is buried way out past three beaches, where Tourist walk everyday on the beach trail, near the airport. She passed in 1900. My great Tutu's are buried in three different family grave sites in the State Park. My Tutu's, Mother, Aunties, Brother and Sister are all buried within the State Park lands.

This should show you how long our family have resided in Honokalani. The road to enter the Cabins and State Park is still privately owned by our ohana.

My husbands Kalawa ohana has also been on this aina since his Great Grandfather, who is buried on this aina we live on, but we do not qualify for Kuleana taxes. Kalawa purchased then married English and has been on this aina from a long long time ago, at least three, now four generations. We can still afford it right now, but very concerned for the future of our children and theirs.

Oprah bought two homes just down the road from us (Kingdom Come?) and owns large pieces of land on either side of us. We can't compete with O. Please pass this bill so our people can remain on the aina for many more generations to come.

_Ohana living on their ancestral lands have made important contributions to Maui communities through their genealogical, cultural, scientific, and historical ties to the __ina. Places have their names, and community knowledge has been developed through working and living on the land over time. Such things as the movement of water, farming, fishing, and sustainability practices were developed, harnessed, and transmitted from one generation to another. __ina k_puna are a substantial part of our very identity and we serve as the stewards to the __ina.

As time has passed and the landscape of our communities has changed, those with __ina k_puna who have found a way to hold fast to their lands are having an almost impossible time struggling to pay for their property taxes as it has increased beyond reasonable means and average local incomes. For example, the property tax where my father grew up and lives (at 89 years old) increased 380% between 2015-2019 due to high-end speculation homes built on surrounding properties. Owners in these homes visit only a few weeks a year are not residents and sell them later for a huge profit.

I humbly ask that you support the __ina K_puna bill BFED-78 CC 21-29 and pass it out of your committee and encourage others in the Council to do so. Standing for this bill is also standing for our Maui long-time kama_ina families and the many contributions they have made to our County and these precious places we call home from our various __ina kupuna, our ancestral lands.

However, due to obscene skyrocketing property values associated with property taxes, real estate, foreign investment and global demand for land in Hawai_i......we are being taxed on our family land, which has not had a hale (house) on it for over 100 years, no plumbing no electricity, no road(s), no new improvements.....in other words, just land, just _aina, _Aina Kupuna. Aloha Budget, Finance, and Economic Development Committee Chair Keani N.W. Rawlins-Fernandez, and Members. My name is Lein__ala Kuloloio Vedder and I support the __ina K_puna bill BFED-78 CC 21-29 that provides tax relief for lineal descents who continue to live and care for their ancestral lands.

As a post-missionary lineal descendent of Honua_ula, my family have been displaced by forcing to sell our ancestral property because of land speculation, developer intimidation, and ridiculous sky-rocketed property taxes. We have other parcels that are encroached upon by future developments in Mo_oiki, Honua_ula that have cause anxiety and financial hardship to pay property tax. The continued increase of development from Paeahu to Keoneo_io have caused Hawaiian lineal descendants to use their ancestral lands for "commercial purposes" in order to sustain their lands and pay for the taxes and fees incurred to maintain the property and infrastructure that are assessed by an unfair formula used by the County of Maui Tax Real Property Tax Assessment Division. Therefore, there may be some lineal descendant families who may not qualify under this bill at this time. Please consider to find a way such as a temporary "limited commercial use" for those families or a moratorium of increasing their property taxes in the interim.

One point I would like to address is the political definition of "kama__ina". The indigenous peoples of Hawai_i have been politically scrutinized of our identity for over two hundred years. Politically, Native Hawaiians are the indigenous peoples of Hawai_i by which we have to prove our identity by providing legal race claim documents. Is the definition of the word "kama__ina" a "native-born, one born in a place, a land child" according to Pukui the official definition? I would also like this committee to define who are "kama__ina" applicants establishing their lineal descendancy by court order to a person who held title to the property as of the date on this bill. I am confident that appropriate legal genealogy race claim documents will be used as evidence of their claim. This is necessary by not causing confusion among others who have been so privilege and not go through identity race claim verification scrutiny like "Native Hawaiians."

I am hopeful that once this bill is passed, discussions among all stakeholders and institutions will continue to protect the inherent interests of lineal descendants on ancestral lands and our future generations of Hawai_i pae__ina.
